Conditions of Entry:

1. All work must be for sale and be priced to sell quickly. You may replace sold work
2. Exhibitors are expected to contribute in some way to the running of the Bazaar
3. Artwork for hanging must be dry, well presented and have a secure cord attached. No metal photo type hangers and no string and tape.
4. **You must label all work BACK and FRONT giving artist's name, title of work, medium and price.**
5. **If you are discounting your work, show the original price then the new price. Buyers love a bargain at this time of year.**
6. Whilst all care will be taken by Gallery staff, MCAA accepts no responsibility for any damage or loss. Insurance is the responsibility of the exhibitor.
7. MCAA reserves the right to refuse any entry considered unsuitable for general exhibition.
8. MCAA acts as the agent for this Bazaar and sale of artworks. **A 20% commission will be charged on all sales.**
9. **All entries must be the original creative work of the artist. Artwork cannot be copied, either wholly or in part from any published article.** Personally owned photographs may be used as reference for subject matter. **You may not sell work created by someone else.**
